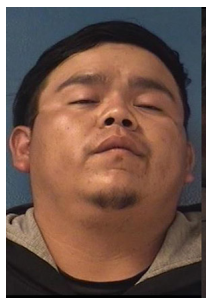

Her boyfriend, who was also intoxicated, said that Mason, 32, locked him out of their house and took off in his car. From there, she was taken to the hospital for medical clearance where she failed the field sobriety tests. She blew a BAC of .18 and .17.

Blackhorse, 30, was pulled over for speeding when the officer noticed he smelled of booze. He failed to pass the field sobriety tests and was booked for his first DWI. He blew a .15 – twice.

* In New Mexico, it is illegal to drive with a breath or blood alcohol concentration of .08 or more if you're 21 or over, or .02 if you're under 21, or .04 if you drive a commercial vehicle. You can be convicted of DWI even if the breath or blood test is below the legal limit if it is proven that your ability to drive was impaired to the slightest degree by drugs or alcohol. – MVD New Mexico
